Agreement of the Sharing of Traffic Speed Sign

This Agreement is made between:
Awbridge Parish Council, a parish within the scope of Test Valley Council (Awbridge)
and
Broughton Parish Council, a parish within the scope of Test Valley Council (Broughton)
Scope
Whereas the parties agree to share the costs of the usage and relocation of the Traffic Speed Sign within each Parish.
The costs for the usage and relocation of the Traffic Speed Sign will be shared equally between both Parishes
The Traffic Speed Sign will be relocated between each Parish alternatively on a regular basis by a Subcontractor appointed by Awbridge.
Detail
Subcontractor will invoice Awbridge for relocation services for both Parishes typically on a monthly basis.
Invoices will be submitted in full to Awbridge Parish Clerk/RFO (Responsible Financial Officer)
Awbridge Parish Clerk/RFO will, on a quarterly basis, present an invoice to Broughton to a value of 50% (fifty) of the value of invoices for that period
Broughton agree to satisfy such invoices upon receipt and approval from their Parish Council.
