## Highways Information

### Hampshire Highways October update

Here's the latest update from County Highways detailing their work in Test Valley during October.



## Proposals for improved crossings on the A36

I've held a productive meeting with the planning team at New Forest National Park and Cllr Charles Payne from Wellow Parish Council exploring ways to improve crossing points on the A356, most particularly at the Blackhill/Whinwhistle Rd and Maury's Lane junctions.

The National Park are making a submission to National Highways to press for these works, so I am hopeful of some movement on these long intractable issues.

## Southampton Road, Romsey - roadworks

The roadworks to allow for the construction of the new cycle path along Southampton Road have now been suspended until after the New Year. The suspension has been put in place to ensure no disruption to local businesses or those travelling to see family and friends in the lead up to, and over, the Christmas and New Year holidays.

## Salt Bins

A reminder that the [Hampshire County Council](#) salt bins are full throughout the area, they are there for community use, so feel free to use them during icy weather.

Thousands of bins like this one are filled with salt across Hampshire for community use throughout winter. They're used by neighbours on public roads and pavements and can be particularly useful to 'join up' salting from the main road, carried out by our Hampshire Highways salting vehicles, to smaller access roads, or on the pavements.

Spreading a small amount of salt from the community salt bins on the pavements or smaller access roads not covered by highways crews can make a big impact on frozen and icy surfaces. One tablespoon of salt (20 grams) is sufficient to treat one square metre of road or pavement surface.



I've made requests for new bins at Casbrook Fields in Michelmersh and Timsbury and for both the roads and the perimeter foot/cycle path at Abbotswood.

I've also reported damaged bins in Wellow and Lockerley. If there is anywhere else where a new bin is needed, one needs repair or if their salt level is low please let me know and I can make the necessary arrangements.

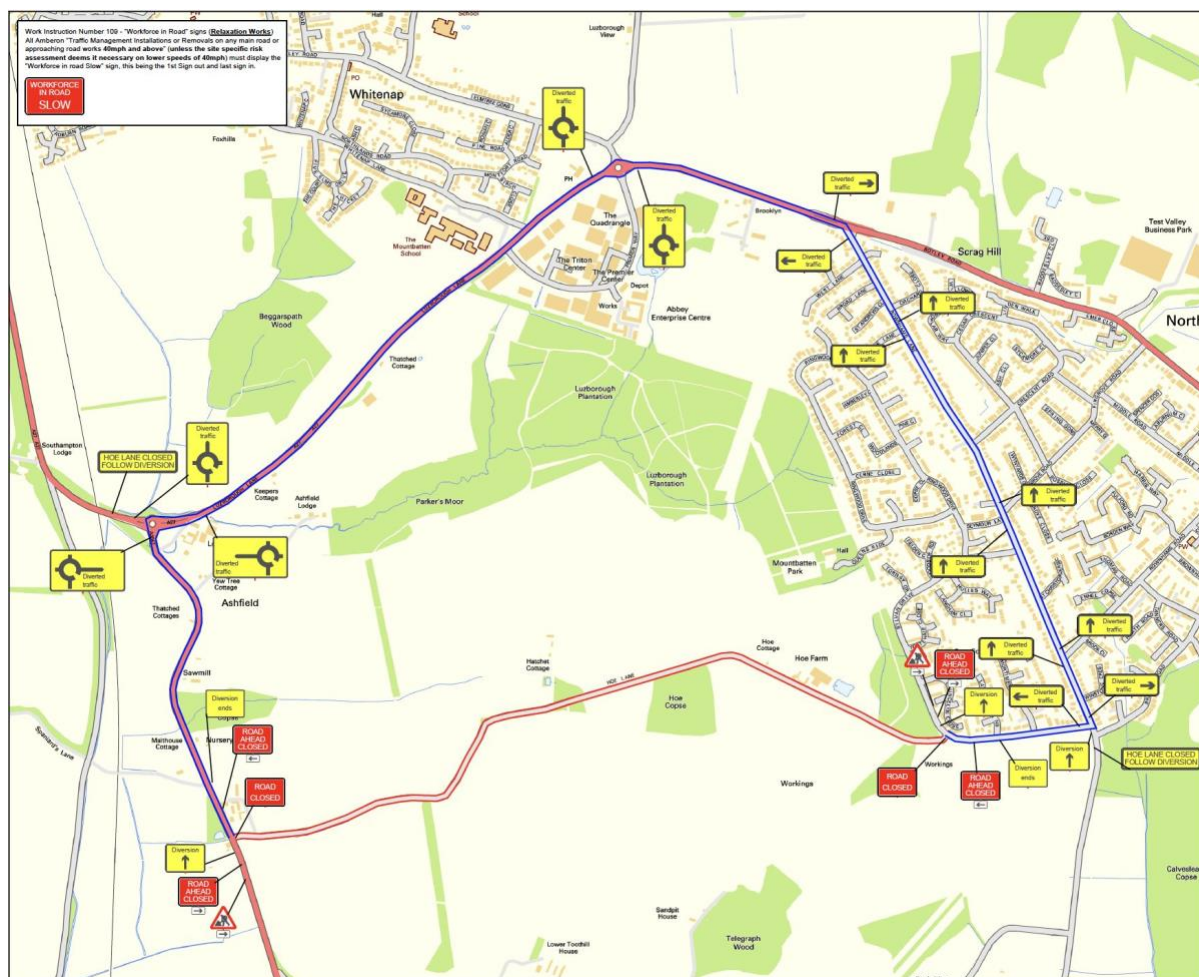
## Closure of Hoe Lane

Hoe Lane is being closed from Monday 6<sup>th</sup> December to allow for work associated with the new housing development there. The closure will last for 16 weeks, until early April 2022.

The works will include drainage, kerbing and surfacing to both the main road and informal passing areas.

Due to the nature of the works in this narrow lane, a road closure will be required to carry out the works safely. Vehicular and pedestrian access to properties in Hoe Lane will be maintained except for a short duration when surfacing works will be carried out.

A plan showing the road closure proposals is below. If there are any delays which mean a longer closure I will let you know.



## **Road Repairs**

### **Works to address flooding on the M271/Romsey Road roundabout**

I have been working to ensure a solution is found to the flooding that affects the exit from the M271 roundabout onto Romsey Road, Nursling by Romsey Golf Club.

I'm grateful to Hampshire Highways who have prepared a scheme to replace the collapsed pipework around the roundabout, clear all the blocked gullies and clear and re-grade the existing ditch to ensure the water flows freely.

The scheme is currently programmed to start in March 2022.

### **Flooding at Romsey Rapids entrance**

An update on the flooding at the entrance to the rapids. Soil percolation tests are currently being undertaken at the site to identify whether a new soakaway can be constructed to help with the issues.

### **Under Road drains connecting ditches**

Having had some complaints in the more rural areas about blocked drains running under roads to connect ditches on either side of them. These drains are now cleared on a reactive basis and no longer rodded as a matter of course.

If you become aware of a drain which may appear blocked, particularly where it causes a flooding issue from the ditch on one side of the road, then please let me know and I will report it in for clearance.

### **Other Highways Issues**

Local roadworks have included repairing the cattle grid at the Blackhill Road/A36 junction and road repairs to Butts Green, Lockerley, Canada Road in West Wellow and Greatbridge Road north of Romsey. I'm continuing to chase repairs to Tanners Lane, Wellow, Old Salisbury Lane and Lee Lane in Romsey Extra, Dean Road, W Tytherley, Stanbridge Lane in Awbridge and drainage issues on Manor Lane in Lockerley.

This month I have also made grants of £250 to The Social Collective Project who help tackle social exclusion and loneliness in Abbotswood and £625 to St Leonard's Church, Sherfield English for their memorial bench project.

### **Another TVBC fly-tipping conviction**

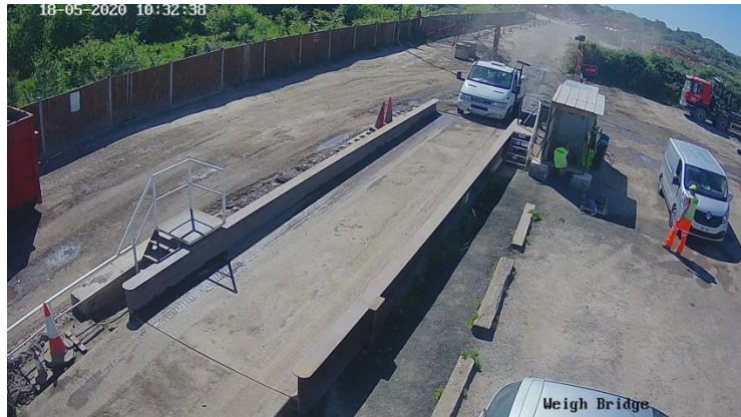
I'm pleased to tell you about another successful prosecution for TVBC, not quite fly tipping, but related.

A man claiming to work for Test Valley Borough Council, causing the authority to be billed for disposing of his waste, has been given a suspended prison sentence and ordered to pay almost £2,000.

Dominic Lane, 23, of Fairbairn Walk, Chandler's Ford, visited a waste transfer station ten times, leaving more than eight tonnes of mixed waste between April and May last year during the national Covid-19 lockdown.



At the site, Mr Lane would claim he was working on behalf of TVBC and asked staff at the transfer station to bill the authority, fabricating an order number. His lies went further, claiming he had been told by the council to collect and dispose of fly-tipped waste, with regular operatives being deployed elsewhere due to the pandemic.



However, what Mr Lane didn't realise is that the council was eventually billed for the waste, meaning an investigation was launched, while working with the waste transfer station. He was then identified as the person responsible.

Mr Lane, who is already on an electronic tag and curfew over Christmas after fly-tipping in May last year along Highwood Lane, Romsey, was given a 17-week prison sentence, suspended for two years. He was also ordered to pay £1,949.10 to the waste transfer station.

This level of deception, claiming to work for a local authority, is absolutely ludicrous, and I am pleased that there is now a prison sentence hanging over the head of the person responsible.

Having previously been in court recently over fly-tipping, these charges and prosecutions highlight the fact that we take every case very seriously, and have an extremely good record of prosecuting successfully.

Fly-tipping, fraud, operating without a licence and other crimes of this nature are simply not worth it. We will always investigate and we will prosecute.

The advice always stands that residents paying to have waste removed should check that the user has the correct licence via the Environment Agency website. We are also on hand to offer advice by calling our team on 01794 57700 or 01264 368000.
