2.1 ASTER SITES LEGAL

East Tytherley parish council are contacting other parishes with Aster sites affected by the ongoing STP issues to ask if they would be prepared to contribute a small amount towards the cost of appointing a Barrister for advise on this matter. 2.2 TVBC TAX BASE DECISION

Hello Tracy

I have investigated this matter, and also enquired of our Property Inspector who monitored the site during construction and managed the inclusion of the properties into the Council Tax List.

The site in question, namely the former Stanbridge Earls School site, was substantially completed in 2022. Some 153 properties (apparently a couple of units were combined to form larger ones, hence why not exactly 155) were

bought into Council Tax between Dec 2019 and early 2023. They were included in the taxbase figures for Romsey Extra over those years and were then wholly transferred to Awbridge Parish from 2023/24.

I apologise for my previous statement that there did not appear to have been any significant inclusion of these properties in the taxbase, this having occurred earlier than I thought and would also explain why Planning did not include anything for this in their housing projections to me. Unfortunately, I am not a planner and rely on others to keep me informed of matters potentially affecting taxbase numbers.

In summary, this retirement complex has been incorporated into parish tax base figures between 2019/20 and 2022/23. I hope this addresses any fears that the Parish Council may have had, but please contact me again should there be any further questions. David Ayers
