### Highways Information


#### A3057 Resurfacing

I've been asked a number of times about the state of the A3057 Greatbridge/Stockbridge Road north of Romsey. Particularly the sections through Brook and between Timsbury and Romsey.

I've been chasing for repairs to be carried out, as has my neighbouring County Councillor, [Cllr David Drew](#).

I'm pleased to tell you the whole stretch of the road from Kings Somborne to Greatbridge (just north of the old World of Water site) is being resurfaced.

The work starts on July 7th and is due to run until August 13th. It'll take place overnight and the road will be closed between 8pm and 6am throughout this period. There will of course be access for those who live along the road.



## Improvements to Bakers Drive/Romsey Road/Redbridge Lane junction in Nursling.

HCC has announced a consultation on their proposals to improve the Bakers Drive/Romsey Road/Redbridge Lane junction in Nursling.


The proposals involve the installation of traffic lights which will be linked intelligently to those at the Bakers Drive/Nursling Street junction.

It started on the 25th March, and ended on the 22nd April. Sadly though they didn't advertise it particularly well, including not telling me about it either.

**A3057 Nursling Junctions Improvement Scheme**  
3. Scheme Proposals – Nursling Street / Horns Drive



**Key Points:**

- Junction improvement required as part of Redbridge Lane (Fen Meadows) and Rowham's Lane planning approval
- Current proposed option straightens alignment meaning "left out" and "right in" to Bakers Drive can operate in one signal phase significantly increasing efficiency
- Pedestrian crossing points introduced to improve safety and access to bus stops, and local schools
- Intelligent Traffic Signals will link with Horns Drive junction to prioritise traffic flows along the A3057 corridor
- Incorporation of vehicle activation and bus priority technology

4. Scheme Proposals – Nursling Street / Horns Drive



**Key Points:**

- Targeted modifications to improve existing junction efficiency
- Link with Bakers Drive junction to prioritise traffic flows along the A3057 corridor
- "Stop Lines" moved closer to A3057 to reduce delays and improve efficiency of operation
- Proposed localised widening of side roads and improved visibility
- Incorporation of vehicle activation and bus priority technology



## **Homes for Ukraine – Local Response**

The local response to the Homes for Ukraine scheme has been fantastic, it's been brilliant to hear of so many Ukrainian families finding sanctuary with local people.

An update on a couple of aspects:

### **HCC Community Grants to help support Ukrainian refugees**

I've had a range of different queries on ways that the County Council can support Ukrainian refugees who are joining communities across the County.

HCC's Leader has established an initial fund of £100,000 which is being made available to support the refugees in whatever ways are most beneficial (on top of the general support agreed through the Government scheme). He has now agreed that this can be made available for community and voluntary organisations to make applications against.

Funding can be applied for through the Leaders Community Grants

· Applications will be considered from Parish and Town Councils and local branches of national charities (where the support being provided is delivered specifically in Hampshire)

- Applications can be made at any time for amounts under £5,000
- Applications will be assessed to ensure that the proposals are appropriate, that necessary levels of safeguarding are in place and that the activity does not unnecessarily duplicate support which is already provided through other channels.

### Sewerage services provided by Aster?

I've been contacted by a number of residents, living in homes where the sewerage or package treatment plant is still in the ownership of Aster housing association (these are normally sites with former council houses, some of which have been sold while others remain in housing association ownership).

These residents are being asked to pay well over £1,200 per year for their sewerage. I'm interested in hearing from any residents who are being faced with similar charges. So far, I am aware of cases in Awbridge, Lockerley, East Dean, Carters Clay, West Dean/West Tytherley, Over Wallop and East Tytherley.

I'm also talking to colleagues in other areas, including Dorset, who have similar issues being reported to them. My colleague in Dorset is a former Cabinet Member for Housing and therefore has good links to senior management in Aster. Our intention is to pull together case studies to identify the issues people are having and also the complete lack of transparency around any of the charges. Then to present it to her contacts to try to obtain both clarity and solutions for the various sites.

I have two suspicions with the annual management charges, firstly that there is a blanket charge applied to each plant which is then divided by the number of houses served by it, consequently meaning some residents receive enormous bills, while others seem to pay relatively little. Secondly, that the charges are only applied to the privately owned homes, there being no transparency around whether Aster pick up a proportionate share of cost for the homes still in their ownership.

## Romsey Town/Romsey Extra Parish merger consultation


A consultation is underway which recommends the merger of Romsey Extra and Romsey Town parishes into one 'Greater Romsey' parish council.

One small area of Romsey Extra parish would be excluded from the merger and transferred instead to Awbridge. This is the part of the parish to the north of Old Salisbury Lane, including the Audley Stanbridge Earls retirement village. This would include the properties on the northern side of Old Salisbury Lane, but not those on the southern side of the land, nor Roke Manor itself,(see the second map below).
